Your contracting organisation will provide airline tickets from the designated airport in your home country to a designated international airport in Japan. Transportation costs from the airport in Japan to the Post-Arrival Orientation venue, accommodation costs during the Post-Arrival Orientation, and transportation costs from the Post-Arrival Orientation venue to the contracting organisation will be borne by your contracting organisation. It is for these reasons that if you are disqualified or withdraw your intent to participate on the JET Programme after receiving a placement (not including exceptional cases such as on humanitarian grounds), you **must pay any and all related cancellation fees** incurred (including fees for housing if your contracting organisation has already made arrangements).

In addition, if you engage in conduct deemed inappropriate for a JET Programme participant (such as returning home without authorisation, threatening or indicating bodily harm, engaging in harassment or violent behavior, etc.) from the point you arrive in Japan until the point you leave the Post-Arrival Orientation venue for your contracting organisation, this may result in your **immediate disqualification** from the JET Programme. In such cases, **you may be required to return to your home country** (even before reaching your contracting organisation) and **bear the cost of your plane ticket home. You will also be required to reimburse the price of your plane ticket from your home country to Japan and all other travel and accommodation costs incurred.**

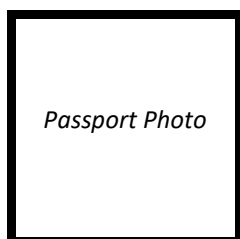
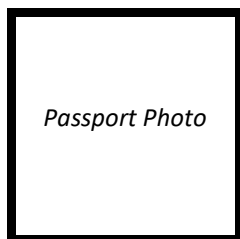
